1 Pending before the Court is the Motion for Preliminary Approval of Class Action  
2 Settlement (“Motion”) relating to the settlement (“Settlement”) between plaintiff Yolanda  
3 DiLorenzo (“DiLorenzo” or “plaintiff”) and defendants Bitdefender Inc. (“Bitdefender”),  
4 Avangate, Inc. (“Avangate”), and their direct and indirect parent companies, direct and indirect  
5 subsidiary companies, companies under common control with any of the foregoing, and affiliates,  
6 agents, employees, representatives, officers, directors, predecessors, and successors in interest of  
7 any of the foregoing, including, but not limited to, Bitdefender S.R.L. and Avangate B.V.  
8 (collectively, “Defendants”). Having read and considered the moving papers, including the  
9 Settlement Agreement, and finding good cause, the Court finds and orders as follows:

10 1. Based upon the Court’s review of the Settlement Agreement, the Memorandum of  
11 Points and Authorities in Support of the Motion, and the entire record, the Motion for Preliminary  
12 Approval of Class Action Settlement is GRANTED.

13 2. The Court hereby conditionally certifies the following class (“Class”) for  
14 settlement purposes only: “All individuals in California who, between December 16, 2015 and  
15 September 16, 2020, purchased software or another product from Defendants and to whom  
16 Defendants made an automatic renewal offer or continuous service offer. Excluded from the Class  
17 are all employees of Defendants, all employees of Plaintiff’s counsel, and the judicial officers to  
18 whom this case is assigned.”

19 3. The Court appoints Dostart Hannink & Coveney LLP as Class Counsel. The Court  
20 appoints plaintiff Yolanda DiLorenzo as the Class Representative. The Court designates CPT  
21 Group, Inc. as the Settlement Administrator.

22 4. The Court preliminarily approves the Settlement, including the monetary relief,  
23 injunctive relief, procedure for payment of Class Counsel’s attorneys’ fees and litigation expenses  
24 to the extent ultimately awarded by the Court, and procedure for payment of a service award to the  
25 Class Representative to the extent ultimately awarded by the Court. The Court has reviewed the  
26 monetary relief and the injunctive relief that are provided as part of the Settlement and recognizes  
27 the value to the Class. It appears to the Court on a preliminary basis that the Settlement is fair,  
28 adequate, and reasonable as to all potential Class Members when balanced against the cost and

1 uncertainty associated with further litigation of liability and damages issues. It further appears  
2 that settlement of the Action at this time will avoid substantial additional costs by all parties, as  
3 well as the delay and risks that would be presented by the further prosecution of the Action. It  
4 also appears that the Settlement has been reached as a result of intensive, serious, and non-  
5 collusive arm's-length negotiations.

6         5. The Court approves the emailed Summary Class Notice (Exhibit A to the  
7 Settlement Agreement), the mailed Summary Class Notice (Exhibit B to the Settlement  
8 Agreement), the Long Form Notice (Exhibit C to the Settlement Agreement), and the paper Claim  
9 Form (Exhibit D to the Settlement Agreement). The notice procedure described in the Settlement  
10 Agreement meets the requirements of Rule 3.766(d) of the California Rules of Court and due  
11 process, and constitutes the best practicable notice under the circumstances. The parties and the  
12 Settlement Administrator are directed to disseminate the Summary Class Notice to the Settlement  
13 Class Members as described in the Settlement Agreement, and to take all steps necessary to  
14 establish a settlement website. The date on which the Summary Class Notice is emailed or mailed  
15 is the "Notice Date."

16         6. As set forth in the Settlement Agreement, any individual who wishes to exclude  
17 himself or herself from the Settlement Class shall mail, email, or deliver to the Settlement  
18 Administrator a written request for exclusion no later than forty-five (45) days following the  
19 Notice Date. Class Members who do not timely request exclusion shall be bound by the provisions  
20 of the Settlement Agreement and all orders or judgments that may be entered by the Court.

21         7. Class Members may object to the Settlement or to any of its provisions either orally  
22 or in writing. Any written objection shall be filed with the Clerk of this court and served upon  
23 counsel for the parties and the Settlement Administrator no later than forty-five (45) days  
24 following the Notice Date, or else such objection will be waived. Any written objection shall be  
25 served by hand or by first-class mail upon the Settlement Administrator (CPT Group, 50  
26 Corporate Park, Irvine, California 92606); Bitdefender's counsel (Oleg Elkhunovich, Susman  
27 Godfrey L.L.P., 1900 Avenue of the Stars, Suite 1400, Los Angeles, California 90067);  
28 Avangate's counsel (Chad Fuller, Troutman Sanders, 11682 El Camino Real, Suite 400, San

1 Diego, California 92130); and Class Counsel (Zach P. Dostart, Dostart Hannink & Coveney LLP,  
2 4180 La Jolla Village Drive, Suite 530, La Jolla, California 92037). Alternatively, an objection  
3 may be made to the Court orally at the Final Approval Hearing.

4 8. The parties shall file any motion for final approval, and Class Counsel shall file its  
5 motion for attorneys' fees, litigation expenses, and for a service award to the Class Representative,  
6 on the dates required under the Local Rules and under controlling law.

7 9. A Final Approval Hearing shall be held in this Court, 330 West Broadway, San  
8 Diego, California, Department 75, on May 14, 2021, at 9:00 a.m., at which time the Court will  
9 determine whether the Settlement should be granted final approval. At that time, the Court will  
10 also consider any motion filed by Class Counsel for an award of attorneys' fees, litigation  
11 expenses, and a proposed service award to the Class Representative. Any motions filed in support  
12 of the Final Approval Hearing shall be filed per code. The Court reserves the right to adjourn or  
13 continue the date of the Final Approval Hearing and all dates provided for in the Settlement  
14 without further notice by mail or email to Class Members, and retains jurisdiction to consider all  
15 further matters arising out of or connected with the proposed Settlement. The parties, Class  
16 Members, and any other interested persons should consult the Register of Actions and the San  
17 Diego County Superior Court's General Orders and website for information about whether the  
18 Final Approval Hearing will proceed in person or by remote means.

19 10. Plaintiff is authorized to file a First Amended Complaint which identifies  
20 Bitdefender S.R.L. and Avangate B.V. as defendants and includes the Class definition set forth  
21 above in Paragraph 2. Defendants shall be deemed to have denied all material allegations of the  
22 First Amended Complaint without the necessity of filing an Answer.

23 11. If the Settlement is not finally approved by the Court, (i) the First Amended  
24 Complaint shall be stricken and (ii) the parties will return to the *status quo ante*, as if no  
25 Agreement had been negotiated or entered into, including reversal of provisional certification of  
26 the Class.

27 12. In accordance with the terms of the Settlement, the Court hereby adopts the  
28 following dates for performance of the specified activities leading to the Final Approval Hearing:

1 2 3	7 days after entry of this Order granting preliminary approval ("Preliminary Approval")	Deadline for Bitdefender to provide the Settlement Administrator with the name and last known home or delivery address for those Settlement Class Members with no email address in defendants' records (if any).
4 5	21 days after Preliminary Approval	Deadline for defendants to wire transfer Nine Hundred Twenty-Five Thousand Dollars (\$925,000) to the Settlement Administrator.

Deadline for the Settlement Administrator to mail the mailed Summary Class Notice to Class Members for whom Bitdefender has no email address (if any). This is the "Notice Date."

**NOTICE OF CLASS ACTION SETTLEMENT**

**PLEASE READ THIS NOTICE CAREFULLY. THIS NOTICE CONTAINS  
IMPORTANT INFORMATION ABOUT A PROPOSED CLASS ACTION  
SETTLEMENT. YOUR RIGHTS MAY BE AFFECTED BY THIS SETTLEMENT.**

The purpose of this Notice is to inform Class Members about a proposed settlement (“Settlement”) of a class action lawsuit that is pending in the San Diego County Superior Court (the “Court”). The lawsuit is called *DiLorenzo v. Bitdefender Inc., et al.*, Case No. 37-2019-00066655-CU-BT-CTL (the “Lawsuit”).

This Notice will explain: (1) what the Lawsuit is about; (2) the main terms of the Settlement; and (3) Class Members’ rights and options under the Settlement. A full version of the Settlement Agreement is available on the Website: \_\_\_\_\_.

**To receive money under the Settlement, Class Members must submit a timely and valid Claim. The deadline to submit a Claim is <<Date>>. If you do not submit a Claim by this deadline, you will not receive money under the Settlement and you will be subject to the Release in Section IV, unless you exclude yourself pursuant to Section II.4.**

**I. What the Litigation Is About**

Defendants Bitdefender Inc. (“Bitdefender”), Avangate, Inc. d/b/a 2Checkout.com (“Avangate”), and their respective parent, subsidiary, or affiliated entities (“Defendants”), market and sell computer- or Internet-related software or products. The Lawsuit alleges that Defendants enrolled certain California consumers in automatic renewal or continuous service programs, and posted charges to the consumers’ credit card, debit card, or third party payment accounts, without first presenting the consumers with all of the automatic renewal offer terms in a clear and conspicuous manner as required by law. The Lawsuit alleges that Defendants have violated the California Automatic Renewal Law, Cal. Bus. & Prof. Code § 17600 *et seq.*, and certain other provisions of California consumer protection law. The Lawsuit is brought on behalf of a class defined as follows:

All individuals in California who, between December 16, 2015 and September 16, 2020, purchased software or another product from Defendants and to whom Defendants made an automatic renewal offer or continuous service offer. Excluded from the Class are all employees of Defendants, all employees of Plaintiff’s counsel, and the judicial officers to whom this case is assigned.

Each individual within the foregoing Class definition is referred to as a “Class Member.”

**Defendants deny the allegations of the Lawsuit. The Court has not decided which party is right. The parties have agreed to a Settlement to provide certain benefits to eligible Class Members and to resolve the case without any admission of liability or wrongdoing.**

The parties have exchanged detailed information about the claims, defenses, and alleged damages in the Lawsuit. After lengthy settlement negotiations overseen by an independent mediator, the parties have reached a proposed Settlement that, if approved by the Court, will resolve the claims asserted against Defendants. Plaintiff and her counsel believe the Settlement is fair, reasonable, and in the best interests of the Class Members. In entering into the Settlement, Defendants continue to deny any and all allegations of liability, fault, or wrongdoing asserted in the Lawsuit.

On \_\_\_\_\_, 2020, the Court preliminarily approved the Settlement; certified the Class for settlement purposes only; appointed the law firm of Dostart Hannink & Coveney LLP as Class Counsel for settlement purposes only; appointed Yolanda DiLorenzo as the Class Representative, for settlement purposes only; designated CPT Group, Inc. as the Settlement Administrator; and authorized the parties to provide this Notice to the Class.

## **II. The Main Terms of the Settlement**

Subject to Court approval, the main terms of the Settlement are as follows:

1. **Settlement Amount.** In full and complete settlement of the claims of the Class Members who do not exclude themselves, Defendants will pay the principal amount of Nine Hundred Twenty-Five Thousand Dollars (\$925,000.00) (the "Settlement Amount"). The Settlement Amount, plus any interest thereon, will be used to pay Class Counsel's attorneys' fees and litigation expenses (as approved by the Court), any service payment that the Court may award to the Class Representative, the expenses of settlement administration (including class notice), and the settlement payments to the Class Members who submit timely and valid Claims. If any funds are remaining by reason of uncashed settlement checks or otherwise, the remaining amount will be paid to one or more *cy pres* recipients approved by the Court, or as otherwise directed by the Court. In addition to the monetary consideration, the Settlement also includes injunctive relief.

2. **Notice to Class Members.** No later than twenty-eight (28) days following the Preliminary Approval Date, Bitdefender will email the Court-approved Summary Class Notice to the last-known email address of each Class Member, to the extent that is reflected in the business records of Defendants. If the business records of Defendants do not contain an email address for a Class Member, no later than twenty-eight (28) days following the Preliminary Approval Date, the Settlement Administrator will mail the Court-approved Summary Class Notice to the last-known mailing address of that Class Member, as reflected in the business records of Defendants, or an updated address provided by the U.S. Postal Service. Before mailing, the Settlement Administrator will run the mailing addresses through the U.S. Postal Service's National Change of Address database, and will update the addresses accordingly. The date on which the Summary Class Notice is emailed and mailed as set forth above is referred to as the "Notice Date."

3. **Submission of Claims; Eligibility for Payment.** In order to qualify to receive a payment under the Settlement, Class Members must submit a Claim that is both (i) timely and (ii) validated by the Settlement Administrator. To be timely, the Claim must be submitted to the Settlement Administrator on or before <<Date>> (the "Claim/Exclusion/Objection Deadline"). See Section III.1., on the next page, regarding how to file a Claim. Class Members who submit a timely and valid Claim on or before the Claim/Exclusion/Objection deadline will be referred to as "Participating Class Members" and, if the Settlement is granted final approval by the Court, will receive a settlement payment in accordance with the terms of the Settlement.

4. **Right to Request Exclusion or Object.** Any Class Member who does not want to be legally bound by the Settlement can exclude himself or herself on or before the Claim/Exclusion/Objection Deadline, as described on the next page in Section III.3. Any Class

Member who wishes to object to the Settlement may do so either orally or in writing. Any written objection must be filed with the Court and served on Counsel for the settling parties and on the Settlement Administrator no later than the Claim/Exclusion/Objection Deadline, as described below in Section III.4. Alternatively, any Class Member may present an objection to the Court orally at the final approval hearing. Any Class Member who does not request to be excluded from the Class may, if so desired, enter an appearance through counsel.

5. Settlement Payments to Participating Class Members. If the Settlement is granted final approval, after deduction of any Court-approved attorneys' fees, litigation expenses, service payment to the Class Representative, and expenses of settlement administration, the remaining amount ("Net Settlement Amount") will be divided equally between the Participating Class Members. As soon as practicable after the Effective Date of the Settlement, the Settlement Administrator will mail to each Participating Class Member a check representing that person's settlement payment.

6. Service Payment. Class Counsel will file a motion requesting a service payment to the Class Representative not to exceed \$10,000. Defendants have agreed that they will take no position regarding this request, provided the request made to the Court is consistent with this Section. As soon as practicable following the Effective Date, the Settlement Administrator will pay from the Settlement Amount any service payment awarded by the Court.

7. Attorneys' Fees and Litigation Expenses. Class Counsel will file a motion requesting an award of attorneys' fees of up to 38% of the Settlement Amount, plus actual litigation expenses not exceeding \$30,000. Defendants have agreed that they will take no position regarding these requests, provided the requests made to the Court are consistent with this Section. As soon as practicable following the Effective Date, the Settlement Administrator will pay to Class Counsel from the Settlement Amount the attorneys' fees and litigation expenses awarded by the Court. These amounts are all subject to Court approval.

8. Release. Class Members who do not exclude themselves from the Settlement will be deemed to release all of the claims described in Section IV below.

### **III. Class Members' Rights and Options Under the Settlement**

Class Members have four options under the Settlement. If you are a Class Member, you may: (1) file a Claim, which if submitted timely and validated by the Settlement Administrator, will qualify you as a Participating Class Member entitled to receive a monetary payment following final court approval; (2) do nothing, in which case you will not be a Participating Class Member and you will not qualify to receive a monetary payment, but you will be bound by the release in the Settlement Agreement; (3) exclude yourself from the Settlement; or (4) object to the Settlement. The following paragraphs explain these options in more detail.

1. File a Claim. To potentially qualify for a monetary payment from the Settlement, potential Class Members must file a Claim.

(a) Class Members whose name, address, and/or email information is reflected in the business records of Defendants are being sent a Court-approved Summary Class Notice via email or mail, which includes a hyperlink to the Settlement Website or other information which enables those Class Members to submit a Claim electronically via the Settlement Website. The deadline for submitting a Claim is <<Date>>. If you miss this deadline, you will not receive any money under the Settlement, but you will be bound by the other terms of the Settlement if you do not request exclusion from the Settlement.

(b) Potential Class Members who do not receive a Summary Class Notice via email or mail may print a Claim Form from the Settlement Website or request a Claim Form from the Settlement Administrator. A printed Claim Form must be completed, dated by the Claimant, signed by the Claimant, and returned to the Settlement Administrator via U.S. Mail, personal delivery, or email. Upon receipt of a Claim Form, the Settlement Administrator will determine whether the Claimant is a member of the Class based on information provided by Bitdefender. The deadline for submitting a Claim is <<Date>>. If you miss this deadline, you will not receive any money under the Settlement, but you will be bound by the other terms of the Settlement if you do not request exclusion from the Settlement. If you submit a Claim that is timely and that is validated by the Settlement Administrator, you will be a Participating Class Member and, if the Settlement is given final court approval, you will be entitled to receive a settlement payment in accordance with the terms of the Settlement.

2. Do Nothing. If you do nothing, you will not be a Participating Class Member and you will not qualify to receive a monetary payment, but you will be bound by the release in the Settlement Agreement.

3. To Be Excluded From the Settlement. Any Class Member who wishes to be excluded from the Settlement must complete and return a request for exclusion via U.S. Mail, email, or personal delivery, and that request for exclusion must be validated by the Settlement Administrator. The request for exclusion must be in writing, and must list the Class Member's name, address, and telephone number, along with the statement: "I wish to be excluded from the *DiLorenzo v. Bitdefender Inc., et al.* Settlement", or words to that effect, and must be dated and signed by the person requesting exclusion. To be timely, the request for exclusion must be returned to the Settlement Administrator no later than <<Date>>. If the request for exclusion is returned by U.S. Mail, the date of return will be the date of the postmark. If the request for exclusion is returned by personal delivery or email, the date of return will be the date the request for exclusion is received by the Settlement Administrator. Those Class Members who submit timely and valid requests for exclusion in the form described above will be referred to as "Excluded Class Members." Excluded Class Members will not receive any consideration under the Settlement and will not be bound by any provision of the Settlement. Requests for exclusion can be mailed or delivered to the Settlement Administrator, as follows: DiLorenzo v. Bitdefender Inc., et al. Settlement Administrator, c/o CPT Group, Inc., 50 Corporate Park, Irvine, CA 92606; email:                     . A judgment in the action will bind all Class Members who do not timely request exclusion. Any Class Member may enter an appearance through counsel. **You may not submit both a Claim Form and a letter requesting to be excluded from this Settlement.**

4. To Object to the Settlement. Any Class Member who wishes to object to the Settlement may do so orally or in writing. Any written objection must be filed with the Court and served on Class Counsel, Defendants' counsel, and the Settlement Administrator, no later than <<Date>>. A written objection must set forth the name of the lawsuit (*DiLorenzo v. Bitdefender Inc., et al.*, Case No. 37-2019-00066655-CU-BT-CTL), the objector's full name, address, and current telephone number, and the following statement: "I declare under penalty of perjury that, to the best of my knowledge, between December 16, 2015 and September 16, 2020, I purchased software or another product from Defendants in response to an automatic renewal offer or continuous service offer, and I wish to object to the Settlement." The written objection must also state the factual and legal basis for the objection, must attach any documents that the objecting Class Member wishes for the Court to consider, and must identify any lawyer who assisted, provided advice, or represents the objecting Class Member with respect to the Lawsuit or such objection. The objection must be filed with the Court and served by mail as follows: (1) to the Settlement Administrator, at DiLorenzo v. Bitdefender Inc., et al. Settlement Administrator, c/o CPT Group, Inc., 50 Corporate Park, Irvine, CA 92606; (2) to counsel for Bitdefender, Oleg

Elkhunovich, Susman Godfrey L.L.P., 1900 Avenue of the Stars, Suite 1400, Los Angeles, CA 90067; (3) to counsel for Avangate, Chad Fuller, Troutman Sanders, 11682 El Camino Real, Suite 400, San Diego, CA 92130; and (4) to Class Counsel, Zach P. Dostart, Dostart Hannink & Coveney LLP, 4180 La Jolla Village Drive, Suite 530, La Jolla, CA 92037. Alternatively, an objection may be made to the Court orally at the Final Approval Hearing. Class Counsel and Defendants will respond to any objections, as appropriate, either in briefs filed in advance of the Final Approval Hearing or at the Final Approval Hearing. If you intend to object to the Settlement but also wish to receive your share of the Settlement if it is approved by the Court, you must also submit a timely and valid Claim Form as explained above.

#### **IV. Release of Claims by Class Members**

**If the Settlement is approved by the Court and becomes effective, and provided that Defendants have paid the Settlement Amount in full, all Class Members who do not exclude themselves from the Settlement, on behalf of themselves, and each of their respective assigns, executors, administrators, successors and agents, shall be deemed to release, resolve, relinquish, and discharge each and all of the Released Parties from each of the Released Claims (as defined below).** For purposes of this paragraph, "Released Parties" means Bitdefender Inc., Avangate, Inc., and their direct and indirect parent companies, direct and indirect subsidiary companies, companies under common control with any of the foregoing, and affiliates, agents, employees, representatives, officers, directors, predecessors, and successors in interest of any of the foregoing, including Bitdefender S.R.L. and Avangate B.V. For purposes of this paragraph, "Released Claims" means any and all claims, complaints, demands, damages, debts, liabilities, actions, proceedings, remedies, causes of actions or suits, known or unknown, of whatever kind or nature, including but not limited to whether in law or in equity, under contract, tort or any other subject area, or under any statute, rule, regulation, order, or law, asserted or not asserted, arising out of or related to the allegations in the Complaint or First Amended Complaint, including but not limited to the claims arising out of or related to the allegations in the Complaint or First Amended Complaint that have been asserted or could have been asserted in the Complaint or First Amended Complaint.
